Luidia further warrants that under normal use and service, and for twelve (12), twenty-four (24) or thirty-six (36) months, depending on specific Product Warranty, from delivery to a Product end user, the hardware portion of the Products, if used as authorized in accordance with Luidia packaging and documentation, will not have significant defects in materials or workmanship that make the Products unusable. As to any defects discovered after the Warranty Period, there is no warranty or condition of any kind. Luidia makes no warranty or representation that the Products will meet any end user's specific requirements, that the operation of the Products will be secure, uninterrupted or error free, or that all defects in the Products will be corrected. Luidia makes no warranty, implied or otherwise, regarding the performance or reliability of any third party products (hardware or software). Installation of any third party products other than as authorized by Luidia will void all warranties given by Luidia. In addition, use, modification and/or repair of the Products other than as authorized by Luidia voids all warranties.

The express warranty stated above is the only express warranty made to You and is provided in lieu of all other express or implied warranties and conditions (except for any non-disclaimable implied warranties that exist), including any created by any other documentation or packaging. and/or (e) acts of third parties, acts of God, accident, fire, lighting, power surges or outages, or other hazards.

Limitation on Duration of Implied Warranties. Replacement products or parts may be new or reconditioned. Luidia warrants any replaced or repaired product or part for the remainder of the initial warranty period; If an upgrade to Software is delivered with a new limited warranty, then the terms of that new limited warranty will apply only to the Software as upgraded, but will not apply to the original Hardware Device;

Any repaired or replaced Software or Hardware device will be new or refurbished or serviceably used, comparable in function and performance to the original Hardware or Software device, and may include third party items;

Except as otherwise required by legislation in your jurisdiction, costs associated with transport (including packaging) for warranty service shall be at your expense; and Luidia does not provide any warranties regarding any other services provided under this Limited Warranty and disclaims all duties (if any) of workmanlike effort or of lack of negligence regarding such services.
